AIRPORT SECURITY

GATE CODES

Gate code information is confidential, for tenant use only. New codes will be issued only to known tenants. In the interest of safety, please do not share your access code with anyone who is not a tenant.

All non-tenants are asked to check in at the Airport Office. There are special codes for non-tenants seeking access to the Airside. These codes are available on a daily basis from the Airport Office.

GATE SAFETY

Due to high activity levels at Bridgeford Flying Services, please avoid using Gate 3. Tenants should access Airport Road and the hangars through Gate 4.

When approaching a closing gate, please wait for the cycle to be completed, then enter your gate code or use your remote clicker. Please do not "tailgate" through an open gate, as the gate may close on your car!

RAMP SAFETY

In the interest of safety, we ask our tenants to confine vehicle driving to the South ramp hangar area. We appreciate your cooperation.

HANGAR SAFETY

HANGAR INSPECTIONS

All re-inspections of hangars have been completed. Common problems include but are not limited to: NO SMOKING signs not posted, extension cords plugged in, no drip pan for aircraft (where needed), no trash or rag cans as required and over storage of flammable and/or non-aviation related items.

If you have questions concerning your hangar inspection, please call Airport Operations at 707.299.1695.

If you still need a **NO SMOKING** sign or a hangar information packet, they are available at the Airport office. California Fire Code section 1103.2 requires **NO SMOKING** signs be posted in hangars.

AIRCRAFT FUELING

The California Fire Code, section 1106.17.1- Position of Aircraft states: ***"Aircraft being fueled shall be positioned such that any fuel system vents and other fuel tank openings are a minimum of 25 feet from buildings or structures."***

Based on current code, there can be no fueling of aircraft inside the hangars or shade hangars. Thank you for your cooperation in moving your aircraft outside of your hangar for fueling.

PROJECT UPDATES

ELECTRICAL CONDUIT INSTALLED

Installation of electrical conduit on the west side of Runway 18R/36L has been completed. Thanks to all our tenants for their patience during the week long process. This will ultimately serve the future glideslope and PAPI.

CHP FENCE IMPROVEMENT

New fencing has been installed at CHP. This will improve the security of Taxiway Juliet and Runway 24.

FAA TOWER REFURBISHMENT

The FAA tower is scheduled for much needed improvements. FAA tower crew is currently scheduled to move out of the tower and into a "temporary tower" (trailer) in August. They are projected to be back in the tower in November. *During the time the temporary tower is in use, ATIS by telephone will not be available. Please use 124.05 for ATIS.*
